4. Other business

4.1 Heavy Vehicle Access via Cosgrove Rd

TA (NSWP) raised the ongoing issue of continued access by heavy vehicles left into the ILC from Cosgrove Rd. As a result NSW Ports have engaged traffic consultants to provide design options for this entrance to ensure this turn is impossible for vehicles >6m. Once the design and costings have been finalised NSW Ports will be making a submission to Strathfield Council requesting the required alterations to the access road that will prohibit this behaviour in the future.

ACTION: NSWP to prepare submission to the Strathfield Council Traffic Committee in relation to left turn into ILC from Cosgrove Rd

4.2 Signage at Turnout Drive

FA (LINX) advised he witnessed a vehicle turn right from Turnout Drive onto Mainline Dr without giving way to the oncoming vehicle. He observed that the Give Way signage at Turnout Drive may be inadequate which may have been the cause in this instance.

ACTION: NSWP to review placement/height of Give Way signage at this location
