2. Project Construction Update

TA (NSWP) provided an Enfield site update;

- C2 will be handed over to spandex Monday 3rd June 2019
- C1 hand over August 2019, tenancy work underway now
- Handover for F1, F2 and F3 expected 14th June 2019
- H1 & H2 construction to commence construction, 80 days of earthworks prior to construction of warehouse structures
- Precinct E scheduled to commence construction August
- Precinct A negotiations continue with potential tenant

3. Operational Update

3.1 Intermodal Terminal (LINX)

FA (LINX) reported April volumes were down however empty return volumes were good. Volumes remain soft in May, and June likely to be similar. LINX working on securing regional rail operators for consolidation at Enfield and continue to looking for new local customers.

New subtenant expected on site in the coming month.

LINX are experiencing difficulty secure windows at DPWA, have been utilising adhoc windows

April was 1 year anniversary, operational processes continuing to improve, safety focus.

ACTION: LINX requested copy of Monthly trade volumes report. Trade results are located on the NSW Ports website https://www.nswports.com.au/resources/trade-results/, MB (NSWP) to see if there is a mailing list and if LINX can be included.

3.2 Area G Transport Yard (Swift Transport)

GDS (Swift) reported volumes for Swift remain soft, August/September expect volumes will pick up again.

3.3 Operational Interfaces

TA (NSWP) provided an update on the risk assessment of rail crossing on Delec Lane has been completed. Lycopodium completed the review and the current rail crossing meets the expected traffic volume safety requirements. The maximum locomotive speed was reduced to 10km for locos from 15km, the crossing has good line of site and there has been some maintenance work to further improve vision. The crossing is considered low risk due to the line of sight, slow travel speed of locomotives and there are only 3 crossings per day with no wagons.



4. Other business

4.1 Dust Issues – TA (NSWP) raised the issue of dust coming from the Swift site due to the high winds in recent days.

GDS (Swift) believes the dust is coming from the dirt mounds on precinct A, and that the covers are not secured. TA (NSWP) to check if this is the case, but believes the dust is coming from the truck parking area within Swift. GDS (Swift) confirmed Swift do have a water cart and it is in use, he will check and ensure it is being used.

There will need to be some discussion in regards to the future/development of the area. With the precinct now commencing warehouse operations this is an issue. Swift have been advised that once construction is complete it will be their responsibly to ensure road areas are free from dirt and mud.

ACTION: TA (NSWP) to ensure Precinct A site dirt mound covers are in place and secure

ACTION: GDS (Swift) to ensure water cart is being utilised to minimise any dust issues from truck parking area

4.2 Speed camera monitors – MB (NSWP) tabled a recent speed data report (Attachment A). The results showed some disappointing behaviour, indicating that on average 461 vehicles per day travelled over Mainline Drive as >50km/hr. The data can be broken down in more detail and MB advised that NSWP will be utilising camera footage to align with speed data and will be reporting speeding incidents to either the appropriate tenant or if necessary authorities. Future plan for the installation of number plate recognition cameras to be installed in Enfield which will further assist with speed monitoring.

Both Swift and LINX were happy to receive reports of speed events, as timely as possible so they could address any issues.

GDS (Swift) suggested that NSW Ports should provide a notice to all tenants of the intent to monitor speed and remind all staff, drivers and visitors that the rules applicable on the Enfield site road are as per the RMS public road rules and penalties apply.

4.3 Trespassers – FA (LINX) reported that NSW Ports' security had identified some trespassers on site in Precinct A in the middle of Monday afternoon. He complemented their timely and effective response in dealing with the issue. The two men advised they had entered the site to take photos of trains, the left the site with no further action required.


