2.1. Flower Power DA (HW)

3.2. Northside Fine Foods

On-site power shutdown on Saturday 18th of November to pull in some new sub-mains, nothing else will be affected. C1 base building will be offline for 2 hours from 0730AM.

3.10. Strathfield Council (JI)

Installed bollards on Hope St to ensure the footpath is protected from vehicle movements.

Discussions are being held to potentially implement cycle-ways along Cosgrove Rd and Wentworth Rd. This is an idea for the future and no designs have been finalised but will advise with further detail once available. Strathfield Council ensure NSW Ports will be a key stakeholder in the concept design as various aspects of the current design and use of the road must be considered, with mitigations implemented where necessary for the project. – **Action:** (JI) to present preliminary designs in the next RTCG Meeting.

Road re-sheeting will be occurring in early 2024 on Hope St.

4. New business

4.1. (MG) General Maintenance Requirements

Re-sheeting on Mainline Road at the front of C1 and C2, line marking has been redone in thermoplastic but has unfortunately started to de-laminate. NSW Ports are aware of it and are in contact with the contractor to rectify the issue.

No other major maintenance works scheduled for any of the road networks within the ILC.

4.2. (SC) Update on traffic observations within the precinct

Traffic observations are trending downwards, with the only common issues being associated with illegal parking within the thatched area on Mainline Drive.

A Safety Alert was issued last week, regarding vehicles failing to stop at the rail crossing.

4.3. (SC) Port and Precinct Security Meeting

Pro-Palestinian protest action has been occurring in Port Botany in retaliation to the Israeli-owned ZIM Shipping Line. It is to note, there have been instances of protesters targeting ZIM operated vessels and trucks carrying ZIM containers. Therefore, if any suspicious activity is recognised in the ILC, please notify the Police and NSW Ports.
